This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:


- Schedule A supporting Line 11(a)(i) of your report discloses receipts identified as "unitemized." Please be advised that federal regulations require the itemization of all contributions from individuals/persons that aggregate greater than \$200 in the calendar year. Please clarify whether this figure includes any receipts that aggregate greater than \$200 from an individual/person for the calendar year and amend your report by itemizing the receipts on Schedule A if necessary. 11 CFR §104.3(a)(2)

**Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter.** Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

2003年8月27日，美国联邦选举委员会（FEC）向泰伯恩（Robert J. Taborn）发出通知，要求其提供关于其2003年中期报告（1/1/03-6/30/03）的详细信息。通知指出，泰伯恩的报告中包含一些未列明的收入（unitemized receipts），这违反了联邦法规。委员会要求泰伯恩在9月26日之前提供详细的收入清单，并修改其报告。如果泰伯恩未能提供足够的信息，委员会可能会对其委员会进行审计，甚至采取执法行动。
