The amendment is made in response to a November 26, 2012 letter from Kevin Fortkiewicz. The \$1666.67 contribution to Montanans for Tester has been re-coded to Justice 2012. The check itself was made to Justice 2012, but assigned mistakenly to the Tester campaign, based on how we believed Justice 2012 was itself making its later contributions. On the advice of Mr. Fortkiewicz, this check has been re-coded to Justice 2012. Also on his advice, we have not recoded other contributions where the check was written to Justice 2012 but was later distributed to campaign committees. Thus, the \$1666.67 contributions shown here for Bill Nelson for Senate and McCaskill for Missouri, were also made on a single check to Justice 2012 but not altered. Because limits were not reached for those campaigns, we have been advised by Mr. Fortkiewicz that we need not amend those contribution reports. A \$2947.94 contribution to Braley for Congress has been recoded to General, from Primary, also in reponse to the November 26, 2012 letter. This results in an excess contribution of \$0.10 (ten cents). After inquiry, the Braley campaign has written (on 12-5-12) that it will refund the ten cents. When received, the check will be shown as a receipt on our next report and a copy will be provided to Mr. Fortkiewicz.
