Dear Mr. Morse:

I am writing on behalf of the Association of Fundraising Professionals Political Action Committee (AFP PAC) in response to your letter dated March 5, 2008 regarding the AFP PAC's year-end report (10/01/07-12/31/07).

Per your letter, we have corrected the discrepancy contained in Form 3X of the AFP PAC's 2007 year-end report. Previously, an attempt was made to amend the AFP PAC's July 2007 quarterly report to correctly reflect a \$1,000 contribution that had been made to Senator Charles Grassley on May 14, 2007. For some reason, the amended July 2007 quarterly report, as well as the subsequently amended October 2007 quarterly report, did not upload correctly (unbeknownst to us) to the FEC file. Therefore, the AFP PAC's 2007 year-end report showed a \$1,000 discrepancy in Lines 7, 23, 31 and 32, as well as in the cash balance line item.

With the help of the FEC's technical support staff, the amended July 2007 and October 2007 quarterly reports were properly uploaded on March 11, 2008, as was an amended 2007 year-end report. We have attached hardcopies of the amended reports.

We apologize for any confusion which we may have caused and hope that the amended reports and this response resolve this matter. Please contact us if you have any questions.
