In response to the letters sent to ASAPAC on March 15, 2011 regarding errors and want of clarification of ASAPAC's Amended 30 Day Post-General Report, we are writing to supply the clarification information that you requested.

Amended 30 Day Post-General Report (10/14/10-11/22/10)

ASAPAC filed two amendments to the September and October monthly reports on 12/21/10. The October Monthly Report did not reflect the adjusted "Calendar Year-to-date" total, the Summary and Detailed Summary page(s) and the beginning cash balance of the October Monthly Report from the September and October amended reports. ASAPAC would like to respond that it has filed an amendment to the 12 Day Pre-General Report which will take care of any discrepancies between the 12 Day Pre-General Report and this report.

We would like to notify you that the non-itemization of the independent expenditures on the original report was due to clerical error. ASAPAC filed an amendment for eight independent expenditures supporting "Ami Bera, M.D.," "Bobby Bright," "Larry Buschon, M.D.," "Charlie Dent," "Andy Harris M.D.," and "Mark Kirk" respectively, which had not been itemized on Schedule E, supporting line 24 of the Detailed Summary Page in the original report. A letter notifying you of the amendment was sent December 21, 2011.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 3 item(s):

1. The totals listed on Lines 7, 24, 31 and 32, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.
2. The beginning cash balance of this report should equal the ending balance of your 12 Day Pre-General Report (10/1/10-10/13/10). Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
3. Your amended report discloses additional disbursements totaling \$409,300 on Line(s) 24 of the Detailed Summary Page that were not disclosed on your original report. Please provide clarifying information as to why this activity was not disclosed on your original report. 11 CFR §104.3

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee


