DEFICIENCY 1.

This is a follow up to your letter dated June 30, 2016 concerning the above report, in which you stated that our Campaign received contributions from certain political organizations that were not registered with the Federal Election Commission. Please be advised that of the twelve (12) organizations identified, we have received confirmations from eight (8) of those organizations certifying that the funds donated were permissible (see attached). The remaining four (4) organizations ( i.e : Campaign Funds for Sandra R. Jones, Lester E. Taylor for Mayor East Orange, Committee to Re-Elect Wayne Richardson and Re-Election Fund of Armando F Sheriff, Inc.), that did not confirm, accordingly, we have refunded their contributions ( see copy of checks attached).

DEFICIENCY 2.

With regards to the second deficiency cited in your letter, which stated that we failed to disclose identifications of twelve donors who contributed in excess of \$200.00. Please be advised that through further follow-up, we obtained some, but not all of the missing information, as we continue to receive more information we will update the donors' records.

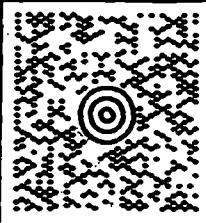

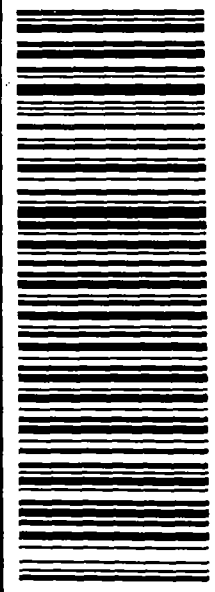
