Women for American Values and Ethics PAC (WAVE PAC) is registered with the Federal Election Commission (FEC) as a hybrid PAC per FEC vs. Carey. Each reporting period, WAVE PAC has been calculating the allocated administrative expenses between the contributions account and the IE account. The bank accounts for each remain segregated. The contributions account has been the primary payor to vendors for allocable administrative expenses. For the Post-General 2020 quarterly reporting period, the contribution account's allocated portion of administrative expenses that will be transferred to the IE's bank account totals \$3,715.02. Funds will be transferred in December 2020. During this reporting period, \$64,000 was transferred from committee's contribution account to their IE account.
