This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 item(s):

1. Your committee filed a 48 hour report informing the Commission of an independent expenditure made in support of "Sen. Orrin G. Hatch" with "Majority Strategies" as the payee(s). However, the election designation disclosed on this report does not appear to correlate with the entry on Schedule E, supporting Line 24 for the reporting period. If your committee has filed a 48 hour report supporting an independent expenditure not reflected on your report, you must file Schedule E during the appropriate reporting period to disclose this payment. Please amend your report to clarify this discrepancy and provide further information concerning these reports. (11 CFR §104.4)
2. Itemized independent expenditures must include a brief statement or description of why the expenditures were made. Please amend Schedule E of your report to clarify the following description(s): "2012 Convention." For further guidance regarding acceptable purposes, please refer to 11 CFR §104.3(b)(3).

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action

will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
