This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your calculations for Line 6(a), Column B appear to be incorrect. FEC calculations disclose this amount(s) to be \$30,620. Please provide the corrected total(s) on the Summary Page.

-The beginning cash balance of this report should equal the ending balance of your 1999 Year End Report. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.


-Schedule B supporting Line 23 of your report discloses a contribution(s) to a candidate(s) for the primary election; however, the funds were disbursed after the election date(s) (pertinent portion(s) attached). Please note that contributions may not be designated for an election which has already occurred unless the funds are to be used to reduce a candidate committee's debts incurred during that election campaign. Please clarify the contribution(s) and disclose any redesignations or refunds as necessary on the appropriate schedules.

-Schedule A supporting Line 11(a)(i) of your report discloses contributions received through what appears to be a payroll deduction plan. Please amend your report to disclose the amount deducted per pay period and the frequency of the deduction. 11 CFR §104.8(b) Please refer to the enclosed sample of properly reported payroll deductions.

-Schedule B supporting Line 23 of your report discloses a contribution(s) to Roy B. Fund. Please clarify whether this is a federal committee(s), as there does not appear to be a committee(s) registered with the Commission under this name(s). In the event this is a non-federal committee(s), please disclose it on Schedule B supporting Line 29 of the Detailed Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Itemize payroll deductions only after they have exceeded \$200 per calendar year from an individual.

Payroll Deductions

Once an individual's deductions aggregate over \$200 in a calendar year, report the total amount deducted from the donor's pay during the reporting period on Schedule A. In parentheses, the amount that was deducted per pay period. Instead of stating a date of receipt, write "deduction" under "Date." The itemized information, including year-to-date total, must be reported for each donor. 104.

EXAMPLE: During an eight-year period, a corporate manager hires her employer to deduct payroll deductions (each pay period, six weeks) for the company's SSF, which files FEC reports quarterly. In the first-quarter report, include the manager's first-quarter contributions (\$90 for six pay periods) as "unitemized contributions" on line 11(a)(1) in the April quarterly report. By June 30 (the closing date for the July quarterly report), 12 pay periods have passed, and the manager's aggregate contributions are \$195—still below the \$200 itemization threshold. The manager's second-quarter contributions are included in "unitemized contributions" in the July report. By September 30 (the closing date for the October quarterly report), 18 pay periods have passed, and the manager's contributions reach \$285. Now the manager itemizes the total contributions received from the manager during the third quarter (\$90), providing a year-to-date total in the appropriate space. (See item A in the example above.)
