I became the treasurer for the Libertarian Party of NC (LPNC) in October 2018. I signed off on my first FEC report in January 2019, a report prepared by our paid accountant. After delving into the report later, I discovered we had been reporting an incorrect balance for several years. I have investigated as far back as 2014. To the best of my knowledge, here is the most accurate information I can verify.

In January 2016, in the Year End Report covering 7/01/15-12/31/15, the balance on the FEC report is \$395.71. At that time, our actual bank balance was \$446.56. We had a surplus of \$50.85.

The report covering Jan 1 2016 thru March 31 2016 reports a balance of \$0. During that report period, LPNC had one expense for a credit card payment on Jan 29, 2016 of \$65. The bank balance is \$381.56, as of January 31, 2016.

The FEC report covering April 1 2016 thru June 30 2016 also reports a balance of \$0.
