Re: C00461046, 30 Day Post General Report (10/14/10 - 11/22/10)

We are in receipt of your letter of January 6, 2011 requesting further information for the 30-Day Post General report.

1. Contributions not appearing on the report - you have indicated 4 items that were reported as 48 Hr Notices but do not appear on the report.
 - a. Alan Schwartz, \$1000 - this check was received on October 22 but was never deposited and never recorded in our donor database. We believe the check was misplaced.
 - b. Pennsylvania Empowerment PAC, \$1000 - this contribution was recorded and deposited on October 23 but did not appear on our report due to an improper designation as a State Office Committee rather than a PAC. This has been corrected and the contribution will be included in our Amended Report.
 - c. Job PAC, \$3000 - this contribution is from a Committee known as JOE PAC and was recorded and deposited on October 27 but did not appear on our report due to an improper designation as a Party Committee rather than a PAC. This has been corrected and the contribution will be included in our Amended Report.
 - d. Jack Conroy, \$1000 - this is an in-kind contribution that appears on our report as John Conroy, rather than Jack. Additionally, the correct in-kind amount was \$1400, an increase from what was initially reported on the 48hr notice.

2. Missing 48 Hr. Notices. -
 - a. The following notices were missed and were noted as such on our Form 99 filed with the Post-General report: McClintock for Congress \$2000, Madison Project \$2745, Charles Boyle \$1000, William Mow \$1000, Mrs. Donald Meske \$1000, I.A. Morris \$1000. A copy of that Form 99 is attached. We regret that the 48 hr notices for these contributions were not properly filed.
 - b. Kurt Heyman \$1000 - we did file a 48 Hr notice for Mr. Heyman on 10/19, however his contribution was duplicated in our database and therefore it appears that we missed a 48 Hr. Notice - we did not, he made only 1 contribution of \$1000 and this change will appear on our Amended Report.


- c. On the Form 99 filed with our Post-General report we noted that a number of Earmarked contributions were received in the 48Hr notice period through the Senate Conservatives Fund (a conduit). The individual contributor information for these conduit contributions is not generally received by our office until after the check has been processed. In the case of the following contributors that information was not received until after the 48Hr notice period had passed: *Wendy Kolokotronis, Michael King, Ray Larsen, Mary Scrivner, Stephen Way, Richard Dean, Sean Brady, Michael Amini, George Vradenburg and Lenore Broughton*. In the future we will make an effort to get the donor data sooner to avoid this type of situation. I would like to clarify that all contributions received from the Senate Conservatives Fund were properly reported as 48 Hr Notices.

j. Gail Miller - this contribution is a reattribution memo and does not require a 48Hr notice
k. JP Morgan Chase PAC, Richard Fiore, Michael Fiore, Leonard Fiore, Fox Rothschild LLP - these contributions were all Transfer Memos related to a contribution received by our Committee on 11/22/2010, well after the 48Hr notice period.
l. John Conroy - see item 1(d) above - 48 Hr notice filed as Jack Conroy.

I understand how important this reporting function is and will do my best to be fully compliant with all regulations for reporting "last minute" contributions in the future. To that end we will provide additional training for all staff responsible for handling contributions to be sure they understand the extremely important nature of 48 Hour reporting.

3. Disbursement Description - this disbursement to Red Sea, LLC has been changed to Media Consultant Fee and will be reflected as such on the Amended Report. That term has been used on all previous reports.

I believe this addresses all of the items in your January 6 letter. Please do not hesitate to contact me with any further questions or if you require any further documentation or clarification. As mentioned above, an Amended Report for this period will be filed.

- 1) Total earmarked contributions from the Club for Growth for this reporting period = \$43,152
- 2) Excessive contributions appear on this report for 6 individuals (James McErlane, Michael Bowe, John Mattingly, F. Barry Shaw, John Halston and James Bochnowski). In all cases a compliance letter seeking spousal reattribution was sent to the contributor. If we do not receive a reply within the 60 day window the excessive contribution will be refunded to the contributor.
- 3) In the course of reviewing the 558 48-Hr notices that we filed, a number of corrections and omissions were discovered and need to be brought to your attention.
 - a. 10/15 notice filed for Sidney McVey, \$2000. The check was signed by Beverly McVey and appears on this report as a contribution from Beverly, not Sidney.
 - b. 10/19 notice filed for Kurt Gwynne, \$1000. The check was signed by Karen Gwynne and appears on this report as a contribution from Karen, not Kurt.
 - c. 10/25 notice filed for Terrence Jacobs, \$1400. After the notice was filed we realized that Mr. Jacobs had reached the \$2400 limit for contributions and his check was returned to him.
 - d. 10/27 notice filed for Myra Asplundh, \$1000. The contributor name is actually Martha, not Myra and appears on this report as a contribution from Martha Asplundh on 10/27.
 - e. Despite our best efforts to properly report every \$1000+ contribution in that period, it appears that we did miss some, and the list below represents those contributions that were not reported in the 48 Hr notice period. We deeply apologize for this oversight.

 - ii. Madison Project, 10/18 \$2745

 - f. You will note a number of contributions from the Senate Conservatives Fund that appear as 48Hr notices. The SCF serves as a Conduit for earmarked contributions. We generally receive an electronic copy of the contributor information about 1 week after the check arrives and it is then uploaded to our database and linked to the Conduit memo. In a number of instances there were individual earmarked contributions that would have been reported as 48Hr notices but because we did not have that donor data until after the reporting period had ended, they do not appear as 48 HR notices – the conduit check DOES appear as a 48 hr notice, but NOT the individual earmarks that make up those checks. I did speak with our FEC analyst about this and she suggested we make note of this on our report.
