Please find attached amendment of Russ for Wisconsin's 2016 Pre-Primary Report. While performing an end of campaign audit several errors were discovered and are corrected in the attached report.

Corrected errors include:

- \$250 from a redesignation for Barbara Forster was not added back to the general election. This error has been fixed and puts Barbara \$250 over her limits and will be refunded.
- A \$7.31 banking fee to Bend the Arc was originally reported as \$7.29 and has been corrected.
- A \$99.60 banking fee to Council for a Livable World was originally reported as \$79.50 and has been corrected.
- Rent payments to Foxridge Office Park were reported with incorrect amounts and have been fixed in attached amendment.
- A \$500 refund to David Amell was omitted on the original report and has been added.
