This letter is in response to your inquiry regarding the above referenced report.

- Attached please find a copy of the best efforts procedures used by the Committee to obtain required contributor information.
- A review of our filing contains all aggregate year-to-date totals for contributors, which is generated by the computer software Campaign Manager by Aristotle.
- The offset to operating expenditures from Bush-Cheney 2000 Inc./Recount was for travel and accommodation charges detailed in payment made on 12/11/2000 to American Express.
- Attached please find the corrective action we took on 3/14/2002 regarding contributions received from RPAC of NYS. This action will be reported as required on the April 2002 quarterly report.
- The Schedule H3 receipts of \$41,836.85 were incorrectly reported for Direct Mail Jan 2001 expenses. The two transfers were for GC Inaugural 1/17/01 expenses. The amended report corrects for this error.
- The Schedule H4 payment of \$8,918.08 to the non-federal account is for the Bush-Cheney 2000 Inc./Recount receipt and represents the non-fed share of the American Express payment that was made.
- The Schedule H4 payment to Friends of Pataki has been moved to Schedule B and a reimbursement from the non-federal account has been made and will be reflected on the Committee's 6/30/02 filing with the FEC.

- The 100% federal activity for Direct Mail Jan 2001 and Telemarketing Feb 2002 has been moved to Schedule B per your instructions.
- Schedule H2 ratios have been changed to reflect the "revised" and "new".
- The numbers disclosed on the summary page are the correctly audited numbers. The Schedule H4 numbers use a 12.5% federal ratio as calculated by the campaign software for the Schedule H1. When making transfers, the 12.5% federal ratio is rounded up to 13% pursuant to FEC instructions.
- We have included full name and/or mailing addresses on Schedule H4 for all vendors for which we have the complete information.
- The disbursement made to American Express noted "credit for duplicate payment" was for a payment made that was incorrectly posted by American Express. The first payment in this amount was made in November 2000 and applied to the wrong account, so a subsequent payment was made in March 2001 and posted to the correct account.
- The Event Year-to-Date calculations have been corrected.

The enclosed disk reflects the above changes made and is submitted as the amended filing.
