The 2004 Post Election report was amended while the 2004 Year End report was not, creating a discrepancy in the cash on hand amount. The Year End report has now been amended, changing the cash on hand amount on line 6(b) to \$97,931.05 for the July 20, 2006 report. This change corrected an inconsistency on Line 8 between current reporting period and closing calendar year-to-date cash-on-hand. In addition, an ACH error in the amount of \$100 in line 6(c) of the original July 20, 2006 report was removed from the total in the amended report to correctly indicate actual total receipts of \$32,151.75. This correction, along with the corrected cash on hand amount, changes the totals in lines 11(a)i and 11(a)ii, and therefore also change the totals in lines 11(a)iii, 11(d), 19, and 20.
