2. Commission records indicate that your official address is different from the address disclosed on the Summary Page of this report. If your committee has changed its address, please disclose the new address on an amended Statement of Organization or check the address-change box on the Summary Page of your report to indicate an address change. Please provide clarifying information regarding this discrepancy.
3. The beginning cash balance of this report should equal the ending balance of your Amended November Monthly Report (10/1/09-10/31/09), received 2/1/10. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
4. The totals listed on Lines 6(c), 7, 11(a)(i), 11(a)(ii), 11(a)(iii), 11(d), 19, 20, 21(b), 21(c), 31, and 32, Column B of the Summary and Detailed


