This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The totals listed on Lines 7, 23, 29, 30, and 31, Column B of the Summary and Detailed Summary Pages appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.


-Schedule B supporting Line 23 of your report discloses contributions to VOLPAC and Democratic Leader's Victory Fund 2000; however, you have disclosed "Bill Frist (TN-R-Senate)", and "Richard A. Gephardt (MO-3-)", in the purpose of disbursement fields. Please clarify whether these were earmarked contributions made by your committee through VOLPAC and Democratic Leader's Victory Fund 2000 committees to these candidates, or if you made the contributions to the political committees exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidate's name in the purpose of disbursement field. Please amend your report to clarify the ultimate recipient of these contributions.

-Please amend Schedule B supporting Line 23 by providing the office sought (House, Senate, President), state and congressional district, if applicable, for each contribution made. 11 CFR §104.3(b)(3)(ii) and (v)

-Records at the Commission indicate that your committee should be following a quarterly filing schedule; however, the 2002 reports you have recently filed indicate that you are following a monthly filing schedule. Please be advised that 11 CFR §104.5(c) requires political committees to notify the Commission prior to changing its reporting schedule. Please provide further clarification regarding your committee's filing schedule.

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
