2. Schedule A supporting Line 11(a)(i) of your report discloses one or more receipts totaling \$7,394.08 from the "State of Texas" and "Texas Comptroller". Please amend your report to clarify the nature of these receipts.
3. A review of the reports filed by your committee (see attached) indicates that your committee received one or more transfers from "Republican Party of Texas" which has not been disclosed on their report(s) of receipts and disbursements. Please provide clarifying information regarding the source of the transfer(s) received by your committee.



Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
