This is an amendment to the 2008 October 15 Quarterly Report (Q3).

The amendment addresses an official request by the FEC for additional information.

The originally filed October 15 Quarterly Report (Q3) included information also contained in the Pre-Primary Report. The official request for information by the FEC directed the committee to amend the report to include only those financial transactions that occurred during the period August 7, 2008 – September 30, 2008.

The report has now been amended to include only those financial transactions that occurred during the specified timeframe.

In addition, the amended October 15 Quarterly Report (Q3) reflects adjusted Cash on Hand balances from the originally filed report. As a result of a review of the committee's official reports, it was discovered that incorrectly recorded transactions as well as individual transactions recorded more than once, caused an

incorrect calculation of Cash on Hand balances over several reporting periods.

Additional amendments are being filed to reflect the adjustment in the affected reports.


