Dear Ms. Wechsler.

I recently became legal counsel for Family Policy Alliance, f/k/a CitizenLink, f/k/a Focus on the Family Action with respect to compliance with the Federal Election Campaign Act, as amended, and filings with the Federal Election Commission. Family Policy Alliance is an IRS-recognized 501(c)(4) nonprofit organization that occasionally engages in independent expenditures.

In reviewing past filings by Family Policy Alliance on the FEC's website, I discovered that it had filed a Form 5, 24-Hour Report on November 5, 2016, for some independent expenditures and two related contributions. However, based on

the FEC's records, it appears that it inadvertently failed to later file a Form 5 Year-End Report in January 2017 for the fourth quarter of 2016.

Family Policy Alliance had no other independent expenditures and related contributions during that quarter. While not excusing its failure to file the Year-End Report, if it had timely filed that report, the same independent expenditures and contributions it reported in its earlier 24-Hour Report would have been the only expenditures and contributions listed in the Year-End Report.

The FEC's online records also indicate that on or about February 17, 2017, a RFAI regarding the unfiled Year-End Report was apparently mailed to Family Policy Alliance. It, however, has no record of having received the RFAI. It is certainly possible that as the RFAI was addressed to the organization by its original name, Focus on the Family Action -- which was changed seven years before the RFAI was mailed - the RFAI never reached its destination.

When I informed Family Policy Alliance that the Year-End Report had not been filed, it asked me to promptly file the report if possible and bring this situation to your attention. The report has now been filed, and in addition to submitting this letter I will try to reach you by phone early next week.
