Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following $\underline{2}$ item(s):

1. Schedule D discloses the outstanding balance at the close of the period for the debt owed to Baldwin Title Company of Louisiana, L.L.C Politcal Action Committee to be \$14,500. FEC calculations disclose this amount to be \$9,500. Please amend your report to clarify this discrepancy.

2. Schedule D discloses \$14,500 in debts owed to "Baldwin Title Company of Louisiana, L.L.C Politcal Action Committee" (see attached). You are advised that 11 CFR §102.5 prohibits a non-federal account from financing activity in connection with federal elections. Please clarify whether the debts owed to the non-federal account relate to activity conducted in connection with federal elections and if so, provide the date(s) when the original activity was conducted by the non-federal account.

If the debts are owed to the connected organization, please amend your report to disclose the correct name for the creditor.

Although the Commission may initiate legal action regarding the activities conducted by your non-federal account, or connected organization, prompt repayment of the debt and any clarifying information that you provide will be taken into consideration.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
