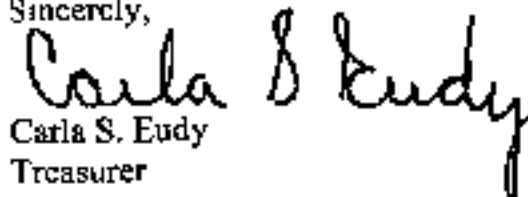
Schedule D has been amended to show corrected payment and outstanding balance amounts with Custom Air Services. The adjusted balances now reflect amended amounts from prior reports.
