The Wholesaler-Distributor Political Action Committee, **FEC ID No. C00109306**, (“WDPAC”) recently filed its FEC Form 3X, Report of Receipts and Disbursements, for the Second Quarter 2012. In Schedule B of the Report, there are two disbursements of \$5,000 each to Romney for President, Inc., each designated as disbursements for the primary election. The disbursements were made on April 3, 2012 (Transaction ID: SB23.6376), and on May 24, 2012 (Transaction ID: SB23.6389).

The second disbursement made on May 24, 2012 was erroneously designated as a disbursement for the primary election, when it should have been designated as a disbursement for the general election.

By letter dated July 25, 2012, Romney for President, Inc. advised WDPAC that its total primary election contribution of \$10,000 exceeded the \$5,000 limit applicable to a multicandidate committee, and according Romney for President, Inc. issued a \$5,000 refund check payable to WDPAC. A copy of the July 25th letter is attached.

On July 31, 2012 WDPAC deposited the \$5,000 refund check in its account. On August 1, 2012, WDPAC issued a \$5,000 check payable to Romney for President, Inc. that was correctly designated as a disbursement for the general election.

WDPAC will be reporting the above refund receipt and disbursement on its Third Quarter 2012 FEC Form 3X. Thank you.
