This submission is in response to the Commission's request for additional information letter dated 1/12/2016. This letter was in regards to the Bennet for Colorado October quarterly report.

- 1) The \$18,000 offset from Google, Inc. was a refund of unused telecommunications from the 2010 cycle. The Committee had paid Google \$18,000 for advertising services on 11/1/2010. The payment was returned to the Committee on 7/17/2015, and thus was not an excessive contribution from Google, Inc. An error in bank account routing information provided to Google resulted in the delay of returning these funds in a timely manner.
- 2) The Statement of Organization was amended on 1/29/2016 to reflect the addition of Searchlight Lake Tahoe Victory Fund as a joint fundraising representative effective 9/30/2015.

We hope this letter addresses the request. The Committee takes its filing obligations seriously and makes every attempt to comply with the requirements. If you need any further information, please contact the Committee.




