1. The beginning cash balance of this report should equal the ending balance of your Year End Report (11/23/10 - 12/31/10). Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
2. Column B figures should be cumulative for a single calendar year. Please amend the Column B totals of your report to reflect 2011 activity only.
3. Your committee has filed a report that contains financial activity already disclosed on another report. Overlapping coverage dates create difficulties in accounting for cash flow from one report to another. Please amend this report by including only the financial transactions that occurred between 1/1/11 and 3/31/11. 2 U.S.C. §434(b)
4. It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 2011-12 election cycle (see attached) and fill in the appropriate coverage dates on Line 5 of the Summary Page.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action

will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
