2 – The excessive contribution to Roksam for Congress was due to a clerical error. The April 5, 2011 contribution made by Nicor PAC was mistakenly attributed to the General 2012 campaign. The proper designation was the Primary 2012 campaign. As the Nicor PAC has been terminated, we are unable to amend this filing to correct the mistake. We have filed a Form 99 indicating this.
