Dear Mr. Andre':

This letter is in response to your letters dated December 23, 1994 regarding the Wisconsin Electric Political Action Committee (WEPAC). The identification number is C00089945.

Enclosed are amended reports for the Amended July Quarterly Report and the October Quarterly report.

On the Amended July report, we made a typographical error on line 11(a) (ii). Our report indicated an amount of 1,156.77. That amount should have been 1,556.77. The total on line 11(a) (iii) is correctly stated at 2,093.02.

On the October Quarterly report, we did not itemize contributions for one of our employees who had contributed more than \$200. You will note that I have revised Schedule A to include Mr. Richard R. Piltz, who contributed \$117.24 in the period, and \$273.56 for the calendar year. This increased the total on Schedule A from 609.24 to 726.48.

I have also revised the Detailed Summary Page. Line 11(a) (i) was revised from 609.24 for the period and 1,596.05 for the calendar year to 726.48 for the period and 1,869.61 for the calendar year. Line 11(a) (ii) was revised from 1,423.09 for the period and 4,491.35 for the calendar year to 1,305.85 for the period and 4,217.79 for the calendar year. Line 11(a) (iii) remains unchanged.

These numbers will now correspond to the amounts reported on the 12 Day Pre-General (10/1/94 - 10/19/94) report.


