Dear Ms. Benitz:

Pursuant to your May 27, 2008 telephone conversation with our Assistant Treasurer, I am responding to your letter of May, 16, 2008 (attached and hereby incorporated herein) in the above referenced mater.

We have verified, and are verifying, that all itemized expenses reflected in our April 2008 3X report have been adequately disclosed. Based on income, we are a small political action committee and must therefore keep our administrative costs to a minimum if we are to fulfill our primary mission, which is to support candidates. Our itemized rental payments include utilities, except telephone, which has been separately itemized to the FEC since 1999. We are also an all-volunteer organization, i.e. no person is employed by us who is salaried or otherwise compensated for their services.

Our income is generated solely by small, individual contributions, generally in amounts under \$25 per donor per year. We have no "secret contributors" or "secret administrative expenses" which we have failed to disclose or to itemize on our report. There also is no person or entity that has been paid an administrative fee for administrative goods such as paper, pens, our one (1) typewriter, one (1) desk, one (1) chair or our one (1) fax machine that has been in excess of \$200 in any given year. Accordingly, we must and do keep administrative costs down as we operate on a shoestring budget.

We try to make do with a small budget to accomplish our purpose, which is supporting political candidates. Per your advice, we will in the future, file a copy of this letter with your office at the beginning of each election cycle.
