This is in response to your letter dated April 2, 2019, concerning the October Quarterly Report (07/01/2018 – 09/30/2018) for Beto for Texas (C00501197).

1. Contributions totaling \$1,000 from the Comal County Democratic Party were confirmed as permissible within the allowed time period, and the rest was refunded on 9/30/2018. Snow for Probate Judge's contribution was confirmed as permissible within the allowed time period. Refunds were issued on 4/30/19 and will be reported on the July Quarterly Report (04/01/2019 – 06/30/2019) for the other unregistered committees you listed in this section of the RFAI.
2. The Jackson Firm PLLC was confirmed as an unincorporated single-member LLC, and the amendment to be filed along with this RFAI response will reflect the contribution being attributed to John Scott Jackson. The in-kind contribution from 290 Vinery LLC was refunded on 10/1/2018 as soon as the committee was made aware that the LLC contribution was not permissible. A refund was issued on 4/30/19 and will be reported on the July Quarterly Report (04/01/2019 – 06/30/2019) for the other LLC contribution you listed in this section of the RFAI.
3. Cari Marshall's excessive contribution was reattributed to Eric de Valpine on 10/15/18 within the allowed time period. Refunds were issued on 04/30/19 and will be reported on the July Quarterly Report (04/01/2019 – 06/30/2019) for the rest of the individuals you listed in this section of the RFAI.
4. To be filed along with this RFAI response is an amended October Quarterly Report to provide addresses for itemized disbursements.

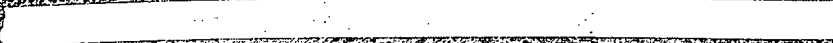
