Attached please find the "Termination" report, covering the period from 10/01/14 through 11/17/14, the day that the campaign account was closed. All of this activity was within the 4<sup>th</sup> Quarter of last year.

I had to do quite a lot of research in order to correct several missing or incorrect Donation entries that did not match actual activity in the account. I am sending the full lists of Donations and Disbursements for your perusal, if you choose to do so. I have always used accrual basis rather than cash basis, so any items that were subject to a significant delay between the Donation date and the date the funds were deposited became available for our use. The On-Line credit/debit card services we used — Piryx, EventBrite, and Square - were responsible for most of these delays. In earlier reports, we had instances of holding checks for several days before depositing them.

I believe that I have matched every donation to a deposit action, and almost all disbursements to a check, a debit card charge, or a cash withdrawal. I never received any explanations of PayPal transactions.

I apologize for the delays, but I found problems everywhere I looked, and it appeared that continuing from the date when I became treasurer would have been futile.


