In reviewing the bank statement covering the period of 07/1/08 through 07/31/08, the copy of the check was discovered. The payee is a former temporary employee who did not have check signing privileges and not only stole the check from the checkbook but also forged the signature of the authorized check signor. A fraud claim has been filed with the bank, which is conducting an investigation. Request by TIPAC to the bank to refund the amounts improperly paid by the bank has been submitted. A second check was also apparently stolen but was not paid during this reporting period. Further information will be provided to the FEC in the next monthly report.
