
After receiving your letter, and consulting with you several times on the phone, the Committee conducted a thorough review of the election-cycle-to-date totals of the contributors itemized on Schedule A of our report, as specified by the Commission in its letter to the Committee. It was determined that several of the contributors had been inadvertent duplicate entries and several were a result of clerical data entry errors. Those records have been corrected and/or combined, in order to accurately show the contributor's cycle-to-date aggregate totals. These corrections are reflected in the attached amendments to the April Quarterly Report, and our figures are now identical to those you have in your records.

In addition, as we discussed, the figures submitted by the Committee for Entergy Corp. PAC, Hayden McIlroy, Daniella Strother, Patrick Williams and Louis Schickel are correct as reported.

The Committee has instituted new accounting procedures to ensure that this type of error does not occur in any future reports. Enclosed you will find amendments to the Mark Pryor for US Senate's 2007 April Quarterly Report.



