
Dear Mr. Culberson,

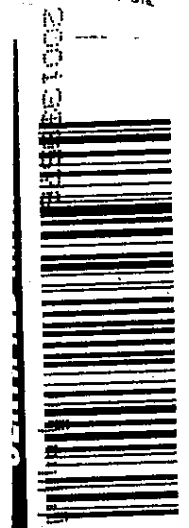
We hope this information adequately addresses your concerns. If you need any additional information, please do not hesitate to contact the Committee.

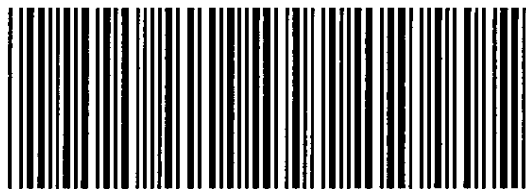
