
Please find attached amendment of Russ for Wisconsin's 2015 Year End Report. While performing an end of campaign audit several errors were discovered and are corrected in the attached report.



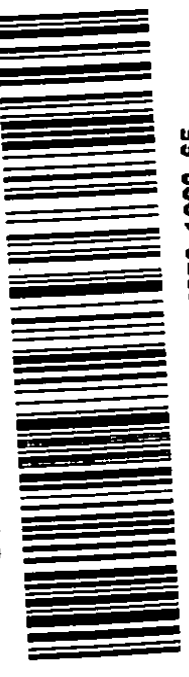

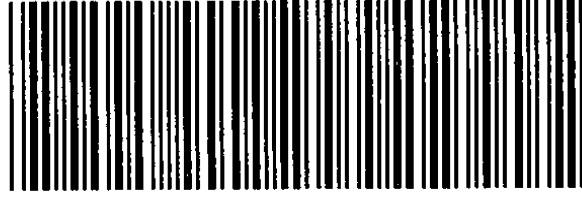
