We are in receipt of your letter dated April 17, 2013 regarding our client's year end Report of Independent Expenditures Made and Contributions Received (FEC Form 5) covering the period October 1, 2012 through December 31, 2012.

Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
