I tried to download the software again from the website and got an error on that, put in an online request for help, and have gotten no response from FEC. I finally was able to open the program but I kept getting error messages, first when I tried to save the report, then when I tried to validate it, and then when I tried to upload it (about 7 times). It says the password is bad but I am using the same password I have been using. My suggestion is to print it out and file it on paper, enclosing the printout of the error message and this email message explaining what happened.
