
This responds to your letter dated February 17, 2011 concerning Restore Our Future PAC's alleged failure to file a Year-End Report, covering the period from October 8, 2010 to December 31, 2010.

Pursuant to Section 104.1(b) of the Commission's Regulations, a committee is not required to file reports under 11 CFR § 104.5 "unless the committee becomes a political committee under 11 CFR § 100.5." According to Section 100.5(a) of the Regulations, "any committee, club, association, or other group of persons which receives contributions aggregating in excess of \$1,000 or which makes expenditures aggregating in excess of \$1,000 during a calendar year is a political committee." 11 CFR § 100.5(a).

During the period cited in your letter, from October 8, 2010 to December 31, 2010, Restore Our Future PAC had no receipts or disbursements. Therefore, it did not fall under the definition of "political committee" set out above. Accordingly, it was not required to file a Year-End Report with the Commission.
