Dear Mr. Solomont:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule H3, Page 4 of 6 of your report, discloses a transfer-in from your non-federal account totalling \$1,500 for Annual Dinner 6/30/92. This transfer appears to occur outside the permissible transfer period. Please be advised that transfers from a non-federal account must be made within a 70-day time period: no more than 10 days before or 60 days after the payment to the vendor. 11 CFR §§106.5(g)(2) and 106.6(e)(2).

The Commission recommends that the full amount of the transfer be returned to the non-federal account. Please inform the Commission immediately in writing and provide a photocopy of your check for the transfer-out. In addition, the transfer-out should be disclosed on a supporting Schedule B for Line 22 of your next report.


Although the Commission may take further legal action regarding the acceptance of impermissible funds, your prompt transfer-out of the funds in question, or clarification of the transaction will be taken into consideration.

-Schedule A of your report (pertinent portion(s) attached) discloses a contribution(s) from an organization(s) which is not a political committee registered with the Commission. Under 11 CFR §102.5(b), organizations which are not political committees under the Act must either: 1) establish a separate account which contains only those funds permitted under the Act, or 2) demonstrate through a reasonable accounting method that the organization has received sufficient funds
