In as much as the election is over, all bills are paid and no debts are outstanding, I request permission to finally terminate and close Stocker in Congress, FEC# C00549287.



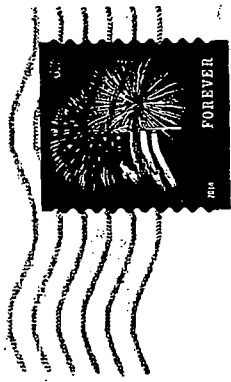
