This letter is prompted by the Commission's preliminary review of the report(s) referenced above. 1. Your committee's name includes the name of a candidate; however, your committee does not appear to be an authorized committee of that candidate. If your committee is authorized by a candidate, please amend your Statement of Organization (FEC Form 1) and choose the correct "Type of Committee." Otherwise, you must amend your Statement of Organization to change the name of your political committee so that it does not include the candidate's name and/or provide further clarification regarding the nature of your committee. (52 U.S.C. §30102(e)(4) (formerly 2 U.S.C. §432(e)(4)) and 11 CFR § 102.14)

2. Your committee has checked the box for Line 5(f) which is used by nonconnected political committees. However, your committee appears to be a principal campaign committee. Please amend your Statement of Organization to clarify this apparent discrepancy.

Please be advised, if your committee has been authorized by a candidate to act on their behalf as evidenced on their Statement of Candidacy, please check the box for Line 5(a) or 5(b). Please refer to 52 U.S.C. §30103 (formerly 2 U.S.C. §433) and 11 CFR §102.2 and the instructions for the Statement of Organization (FEC FORM 1) for further information.

Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
