Dear Mr. Ryan:

This letter will attempt to address some of the issues raised in your letters
of May 2, 2001 regarding the above referenced Report filings for Humane
USA PAC.

With respect to the lack of recorded administrative expenses in any of
these reports, no such expenses are regularly incurred. Volunteers
undertake all work for the PAC and Humane USA PAC does not maintain
independent office space, pay staff salaries, or incur other similar
expenses. There are some expenses associated with mailings that have
been recorded. In any future instance, administrative expenses will be
duly and appropriately noted.

The following notations regard questions pertaining to the 12 Day Pre-
General Report.

- An amended detail summary page is attached which should reflect
the accurate totals in lines 11(a)(i), 23, and any other line for which the
“Calendar Year” totals of Column B was incorrect.
- Schedule B, Supporting Line 23, has been amended to reflect the
office sought, state, and congressional district.

- A new sheet, Schedule B, has been submitted for fundraising mailings. Schedule E detailing independent expenditures appears to have been accurate as reported.
- It has been noted that a separate schedule is required for each activity disclosed on the detailed summary page.

The following notations regard questions pertaining to the 30 Day Post-General Report.

- An amended report is herewith submitted with the correct figures / totals noted for lines 6 (c) and 7 and elsewhere. A new figure has also been calculated for line 8.
- Column B figures for the calendar year have been included.
- The original report as submitted disclosed activity that fell outside the reporting period. This amended report includes only activity between 10/19/00 and 11/27/00. However, it appears that some of the activity originally misreported fell within a *previous* reporting period for which an amended report has already been submitted. Clearly, a subsequent amended report will again be required. Such an amended report (and subsequent reports which require alteration based on this additional activity and the year-to-date figures) will be forthcoming.
- Regarding the refunds from federal candidates for line 16, these amounts (two checks each for \$250) plus two others were actually recorded in the year-end report and appropriately listed on Schedule B therein.
- For all future reporting, a separate Schedule B will be used for lines 23 and 29. As that was not a required component of this amended report and compliance with the FEC letter of May 2, 2001 on this matter, a new schedule is not included here. However, Schedule B has been amended to reflect each office sought, state, and congressional district.


The following notations regard questions pertaining to the Year End Report.

- The excessive contribution on Schedule B is a result of Humane USA PAC qualifying for multicandidate status, but failing to promptly submit FEC Form 1M. This form has since been supplied to reflect the date upon which the PAC so qualified.
- New totals for the detailed summary page have been supplied for Line 11(a)(i) Column B, reflecting amounts in previous amended reports. All subsequent lines have been amended and totaled accordingly.
- Schedule B has been amended to reflect the office sought, state, and congressional district.
