This letter is in response to your letter dated June 29, 2011, regarding the Buck for Colorado Amended Year-End Report (11/23/10-12/31/10), received at the FEC 04/14/11.

Your letter noted the following:

- (1) **Schedule A of the report discloses a transfer from a joint fundraising representative committee; however, the memo entries itemized on Schedule A do not clearly indicate they are in support of this transfer.**

The transfer reported in the Year-End Report was \$8,810.59 from the Buck Colorado Victory Committee, an authorized joint fundraising committee. In the amended Year-End Report filed July 18, 2011, that entry contains a notation: "Final Transfer Net Proceeds from Joint Fundraising Comm."

All of the transfer memos were entered at the time of the first transfer from the joint fundraising committee, 11/2/2010, \$50,527.91. There were no additional contributions to report with the 12/31/10 transfer, which coincided with the termination of the committee.





