Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 item(s):

1. Line 23 of the Detailed Summary Page of your report discloses a total of \$2,000 in Contributions to Federal Candidates/Committees and Other Political Committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$23,000. Please amend your report to clarify the discrepancy. (11 CFR § 104.3(a) and (b))
2. Line 29 of the Detailed Summary Page discloses other disbursements made during this reporting period. If this amount includes any disbursement to an entity that aggregates in excess of \$200 during the calendar year, then this disbursement must be itemized on Schedule B. Please amend your report by itemizing the disbursements on Schedule B or provide clarifying information. (52 U.S.C. §30104(b)(6)(B)(v) (formerly 2 U.S.C. §434(b)(6)(B)(v)) and 11 CFR §104.3(b)(3)(ix))

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
