Dear Ms. Benitz:

I am responding to your letter of May 19, 2004, which correctly notes that Line 23 of Schedule B of our April Quarterly Report discloses a March 18 disbursement to the Oberweis for Senate primary campaign. Your letter states that a March 18 disbursement would be unlawful, as the primary occurred on March 16.

The disbursement in question was check number 1149, for \$2,500. Upon reviewing our records, we discovered that the Quarterly Report mistakenly gave as the disbursement date the date (March 18) that the check cleared our bank account. In fact the check was issued and mailed on March 11, well in advance of the primary election. Chapter 5.3 of the Campaign Guide for Nonconnected Committees states that a mailed contribution is "made" on the date when it is postmarked.

We regret the mistake in our April report. We will soon file electronically an amended Quarterly Report that corrects the mistake. I understand from our telephone conversation today that the amended report is an adequate response to your inquiry. If not, please give me a call at 202 253 5567.
