In response to your correspondence dated November 15 (which we never received) and Mr. Gibson's letter dated December 8, I enclose the following:

1. Detailed Summary Page covering period from 7-15-94 to 8-23-94

Original report filed after we received the letter from you dated September 30 where you clarified the uses of lines 23 and 29. 4. Detailed Summary Page covering period from 10-13-94 to 10-19-94


