This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please be advised that you have included an additional Schedule H1 disclosing an incorrect ballot composition ratio with this report. Only one Schedule H1 must be filed with the first report each calendar year for state party committees. 11 CFR §106.5(d)(2).


-Schedule H3 of your report discloses "Bank of the West Non-Federal Account" as the name of the account for transfers received from your non-federal account for shared activity. Please verify that these transfers were in fact received from your committee's non-federal account and amend your report with clarifying information.

-Itemized disbursements must include a brief statement or description of why the disbursements were made. Please amend Schedule(s) H4 of your report to clarify the following description(s): "consulting production". For further guidance regarding acceptable purposes of disbursements, please refer to 11 CFR §104.3(b)(3).

-Schedule B supporting Line 29 discloses disbursements to the "Bank of the West" for "Other Disbursement Nonfed split refund/v" (pertinent portion attached). Please amend your report to clarify the nature of these transactions and whether the disbursements were to your non-federal account.

A response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
