Empire State PAC has been timely filing with ID C00630681 (which, incidentally, also has the correct address of the PAC which is PO Box 256 in South Salem, NY and not South Salem, CT).

Therefore, I hope this explains why ID C00630673 has not filed. Can you please close/terminate this ID number?

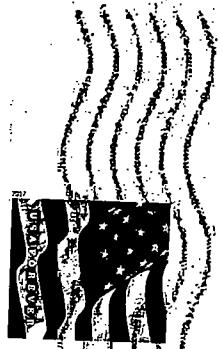

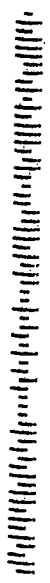
