

After consulting the Committee's RAD Analyst on July 13, Endeavor Action's Treasurer entered a \$340 expenditure on Line 29 as a one-time cash balance adjustment to bring the committee's books into conformity with FEC disclosures. The committee discovered a \$340 variance in the 2020 April 15 quarterly report. Despite multiple attempts to reconcile this variance, which the committee beleives came about due to timing issues with repeated deposits (i.e., misrecording receipts as made more than once), this \$340 surplus (amount reported to FEC above projected cash balance) has remained stable through 2020 and 2021.
