Dear Ms. Benitz:

We received your letter of October 6, 2004 where the Federal Election Commission raised a concern that SunPAC exceeded the contribution limits in making contributions to two federal candidates. We thank you for bringing this matter to our attention. We learned that we made unintentional errors in earlier FEC filings and have since corrected those errors by amending our filings.

Specifically, with regard to the Voinovich for Senate Committee, SunPAC contributions dated 5/01/02, 5/06/03, 9/23/03 and 12/19/03, each in the amount of \$1,000, should have been designated for the 2004 Primary Election rather than for the 2004 General Election. We have corrected this error by amending our June, 2002, June, 2003, October, 2003 and year-end 2003 FEC filings with the proper designations.

A similar error occurred with the Murtha for Congress Committee. SunPAC's 5/27/03 contribution in the amount of \$1,000 should have been designated for the 2004 Primary Election rather than the 2004 General Election. To correct this error, we amended the June, 2003 monthly filing. In checking the FEC website for the Voinovich for Senate Committee and the Murtha for Congress Committee FEC filings, both Committees had the contributions reflected properly so no further actions will be required on their part.

SunPAC's administrator, Comerica, worked with FEC representatives in completing the amended filings who were very helpful. Should you need any further information, please do not hesitate to contact me.
