Dear Custodian of Records:

This letter is prompted by the Commission's preliminary review of the 24 Hour Notice of Disbursements/Obligations for Electioneering Communications (FEC Form 9) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. An adequate response must be received at the Commission by the response date noted above. Additional information is needed for the following 3 item(s):

1. The Commission notes your submission of FEC Form 9, received 2/10/2016. However, the Form 9 was filed after the date of the New Hampshire Primary Election on 2/9/2016. Any person, group of persons, or qualified non-profit corporation who makes an electioneering communication must notify the Commission no later than 11:59 p.m. Eastern Standard/Daylight Time of the day following the date on which the communication is publicly distributed. (11 CFR § 104.20(b)) Please clarify the circumstances regarding the untimely disclosure of the electioneering communication in question.
2. The FEC Form 9 you submitted included a typed signature. Please amend your filing to include the actual signature of the proper official. (11 CFR § 104.20(d) and 104.14(a))
3. On Line 11 of your filing, you have failed to disclose the person or persons sharing or exercising control of the making of the disbursement/obligation for the electioneering communication. You must provide the name, address, employer, and occupation of each person sharing or exercising control. (11 CFR § 104.20(c)(2)) Please amend your filing to include the missing information.

Please note, you will not receive an additional notice from the Commission on this



matter. Requests for extensions of time in which to respond will not be considered. Failure to comply with the provisions of the Act may result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
