To Whom It May Concern: This amendment is in response to the letter dated 8/22/08 for Committee ID: C00413716 concerning the May Monthly Report of Defending Americas Future Political Action Committee. Upon further review of our disclosure reports for the 2008 year, we have discovered an error in our coding for disbursements to federal candidates. This error in coding was responsible for the incorrect totals on the Detailed Summary Page Lines 21(b), 21 (c) and 23. Defending Americas Future PAC has filed an amendment to the 2008 April Monthly Report where this problem originated in addition to this amendment. We believe that following this correction, our May Monthly report totals have been corrected. We will continue to review our disclosure reports and correct any aggregate discrepancies that this amendment may cause.
