This letter is prompted by the Commission's preliminary review of the report referenced above. (2 U.S.C. §434(a)(1) and 11 CFR §104.14(a) and (d))

2. Your report does not include a Schedule H1 to disclose the ratio for the allocation of certain costs. Committees that choose to allocate administrative expenses, generic voter drive costs and expenses related to public communications referencing any party committee (but no clearly identified candidates), should disclose the allocation ratio applied to these expenses on Schedule H1. 11 CFR §104.10(b)(1)

Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
